

# **COUNCIL MEETING Minutes**

# August 1, 2022

Call to Order Jerry Corn called the meeting to order at 1:00.

Roll call 8 Councilors in attendance.

Consent Agenda Minutes from July 2022 were voted on and approved.

Gratitude: Gretchen Holden and Julia Layden expressed gratitude.

# **Update Reports**

# Rose Villa Management Report (Tina Moullet)

#### First Responder Wayfinding

American Medical Response

- Bill Rector provided the name of a person for us to speak with at American MedicalResponse for the purpose of talking about wayfinding for AMR drivers.
- Tina spoke with the contact and was told that the responders to our campus appreciate that our buildings are labeled with signs. They are easy to spot and read, which they refer to locating a residence.
- NEW: AMR will accept a digital file of our campus map. He will make sure the maps are available in responder vehicles.
- He shared that a posted map or other static wayfinding tool would not assist responders. They will not stop and read/look at it.
- Clackamas Fire
  - No changes. They continue using our campus map and posted building signs.

- \* The State of Oregon has created a position within the Department of Health and Human Services. The new Emergency Medical Services (EMS) Coordinator of Safety Oversight and Quality is responsible for staffing the Governor's Senior EMS Advisory Council and is eager to meet with leadership of aging services providers such as Rose Villa.
- \* Tina Moullet will be meeting with the EMS Coordinator on Thursday, August 4.

#### Workforce

- \* CNA, LPN, and RN staffing pressures continue at the local, state, and national levels.
- \* Workforce wage pressures continue to lead the pack when it comes to wage increases across the country.
- \* Workday flexibility and telework continue to pull workers away from jobs that require physical presence at their employer's location (like Rose Villa).
  LeadingAge is acting on behalf of aging services providers through national advocacy, with the goal of attracting more workforce to the aging services field.
- The June 2022 National Conference for State Legislatures focused on the theme for policy making "Addressing Nursing Shortages: Options for States".

#### **Resiliency Action Plan Update**

- Discovery and documentation phase is complete.
- Green Hammer is wrapping up the report for Rose Villa.
- Rose Villa will review and begin scheduling resident meetings to review information and discuss next steps.
- This work will be scheduled asap, within the context of the Phase 3 project workload.
- Resiliency definition in the context of this planning: The capacity to maintain function through or recover from events, threats, or stressors regardless of the magnitude or

frequency.

# RVI Board Meeting (Jerry Corn)

Jerry reported that the Board met last week. The focus was on what was the best for CCRCs. Growth? North Star Senior Collaborative (an umbrella group) has been formed to work on this issue. Vassar Byrd will represent us in the group. No salary but will take some of her time.

**Events Committee** (Gretchen Holden) Gretchen stressed the need for residents to sign up for events, especially bus trips. Full report in attachment. Ann Watt asked about the Ledding Library and the possibility of having a regular bus trip to the library for RV residents. Julia Layden agreed. Gretchen asked them both to talk to Grey and see what could be done. Marilyn noted that residents were having a "Showcase for the Marginally Talented" soon. Gretchen also thanked Marianna Iverson in Madrona Grove for the "Mutts to Madrona Grove" program, which has been quite successful.

**The Foundation** (Elliot McIntire) Louise Williams reported that the Board had approved the expansion of service within the four pillars. The Foundation Board has determined the criteria for the new Community Benefit grants. Description of the grants and application instructions are being printed. The Madrona Grove "Quality of Life" fund has been established. The Foundation is also moving its investment fund to a values-aligned Investment fund. And the Fall festival will not be held because Marketing is planning a fall festival that welcomes the Phase III residents. Cheryl Franceschi will be coming out with more detailed information.

**Treasurer:** (Paul Wathen) Report in attachment. Ann Watt and Marilyn Gottschall asked about money for the Resident Council. Where it comes from, how is it calculated, how much is it, does it change yearly? It was noted that a complete financial report used to be given at each RC meeting but that had disappeared over the years and should be reinstated. A motion was made and approved to ask Paul Wathen (Treasurer) for a regular monthly update on the budget funds.

**Green Team** (Jean Lofy) Felicia Kongable reported the Green Team had 200 lbs of produce from their garden. This was donated to a worthy organization. Volunteers are needed to help with the garden. Felicia expressed thanks to Jan Wainscott and Bill Rector for their work in collecting and recycling plastics, bottles, and cans.

# Agenda – Continued Business

Let's Talk process: Representatives from the Resident Council will meet with Sales and

Marketing to discuss the most common concern from the *Let's Talk* sessions: what health services are available at Rose Villa. There is apparently some disconnect in what Rose Villa Sales and Marketing staff are telling residents and what is actually available.

**ByLaw and Procedures Committee:** A final draft of Revisions to the existing ByLaws was submitted to the Executive Committee, discussed, and approved on July 30. The revisions were then sent to the Communication Committee. This group will work on publicizing, explaining, and addressing questions from the RV community before a vote on the revisions is held in the fall.

**North and South Main filtration question** (from July meeting): Tina explained that both buildings have large air purifiers and can control smoke. This issue is part of the Resiliency Plan.

**Status of iDream Committee:** (from July meeting) Disbanded by members of the committee. The Chair of the committee feels that the Administration is too busy doing other things. Jerry noted that we lost the staff person who was working with the group but thinks we have employees willing to work on this. It is a very important issue. He hopes we can get a replacement and then go back to the Chair and reactivate the group.

**Green Tem Climate Change proposal:** Postponed. This will be brought back to the Council next month.

**Library expansion:** (from July meeting) Cathy Schwabe has worked on a set of plans for the existing library that will expand the linear feet of bookshelf space. The library committee has approved the plan. Now we need to price it and then get it in the RV budget.

## Agenda - New Business

**Satisfaction Survey:** Marilyn addressed the proposed "Satisfaction Survey" and the importance of having support on this issue from Rose Villa management. The cost will be approximately \$3,600 -\$ 4,000. Financial support and input from Rose Villa is needed. The Council can pay for this one time but could not afford to do it every year. Two proposals were approved: to pursue discussions with RV about their contribution and the RC will go forth with

the survey this year even if RV does not agree to participate. The Council liked the ideas and supported both with one abstention on the second proposal.

**Open Forum:** Gretchen asked how/why the Fall festival was canceled and replaced with a "Phase 3" festival without consulting with Events. Apparently, The Foundation decided to cancel and defer the program to Rose Villa Sales and Marketing.
