## Q\&A

Q1. I understand Rose Villa's electrical power is to be switched from Laurie Avenue to a primary feed on River Road. Is that true? If so, when is the work to be completed?
A. PGE power comes into our campus from multiple locations. There are a handful of transformers in our western and central area neighborhoods, currently fed from Laurie Ave, that we are working with PGE to feed from River Road. This is a fairly simple project and will improve that area's resiliency to power outages. We are still waiting on PGE to present their proposal this month and we hope to have this completed before Winter storm seasons come.

Q2. Is there a plan to hide the ugly black boxes on top of the Schroeder Bldg?
A. I'm not positive I know which elements you are referring to. Screening will go up to hide the mechanical equipment on top of Schroeder Lofts on the east, north and south sides. We have also black vent hoods on the side of the building, which ventilates each home. They will not be covered.

Q3. Is there a drinking fountain planned for the south end of campus?
A. There will be a drinking fountain/bottle filler on the south end of the ground floor of Schroeder Lofts. We do not have any plans for outdoor fountains.

Q4. Some of our residents have mobility issues and it makes it difficult to pick up meals, even if they were to use a surrey to do it. I'm proposing that the Delivery Fee be waived for any independent household who has at least 1 resident that uses a cane or walker.
A. Interesting idea. That is a decision for the entire community, whether to subsidize free delivery. It sounds like you're thinking that would be the case even if another member of the household could go and get the meal. While I think that sounds problematic, a proposal to subsidize delivery for a household that truly cannot go get their own food orders - no one in the household can use the surrey and no one is able, with or without assistance, to walk to Harvest Grill - would be something we would need to talk through, as we would with any new fee or subsidy on the campus. This seems like something Tina can discuss with the Resident Council to see if there is really interest to change our practice here, as well as what objective criteria we would use.

Q5. How many employees did we lose due to lack of a COVID vaccine? What departments?

With the shortage of overall qualified workers, Will Rose Villa consider rehire if they comply in the near future?
A. The total number of team members that left due to mandatory COVID vaccine requirement was 9 . The breakdown is as follows:

- Avencia - 3
- Building Operations - 1
- Courtesy Services - 1
- EVS - 2
- Madrona Grove - 2

All these staff will be eligible for rehire in the future, should employment requirements change, or should they decide to get vaccinated (assuming there are open positions available). We also let each of them know we are happy to provide them with a positive reference, as they seek other employment opportunities.
