False alarms from these devices each cost the community \$284. If your device goes off accidentally, please cancel the alert immediately. Emergency responders typically reach campus in 4 to 8 minutes so there's no time for delay.

Health, Wellness and Safety

We have 43 gardeners enrolled. All garden plots but one have been claimed claimed, and we are working on restoring several plots that have lain fallow for years.

Tuesday Market - Susan Hyne and Carolyn Bailey: The Tuesday Market featured a NEW TIME (10:30-11:30am) and a NEW LOCATION OUTSIDE (along South Main) and INSIDE (the Club Room).

The market opened July 2nd with The Parade of the Vegetables. Fresh garden produce and fresh-baked treats were the staples of the market week after week. Staff gave sage advice (for a nickel or more) at the Nickel Booth. Live music spiced up each week's activities. Community tables were hosted by Madrona Grove, Milwaukie Environmental Stewards, Erica Schafer (Beeswax Wraps), Green Team (worm bins and electric cars), and James Carthel (basketry). Kitchen Gardener Arthur Moore and Chef Marty Bracken gave demos. Blueberry sales peaked at 76 buckets (up from 2018 total of 72 buckets). SEEDS sold bouquets, baskets, and more. Eggs were also offered by Marianna Jones (when the chickens were in the right mood). Homemade dog treats by Jennifer Allen and cat grass grown by Darlene Benjamin made our furry friends happy. Market shoppers got tastes of fig chutney, zucchini bread, and tomato sorbet.

An additional Friday Market in the garden barbecue area included fresh produce, garden tours, and BYOL (bring your own lunch), plus root beer floats and homemade ice cream.

PGE Renewable Energy:

Rose Villa is currently considering adopting a renewable energy program. We agree that if this is the best option that Rose Villa has then it should be subscribed to but we are encouraging the Resident Council and the administration to provide more complete information regarding the limitations of the Clean Wind program.

Heat Pumps:

Judy Perry raised the issue of air filtration. Air filters in the classic cottage heat/air units should be cleaned regularly. She also asked about filters that would improve in-home air quality. John Schallberger told us that RV provides heating/cooling but if a resident has concerns about air quality, they should consider purchasing an air filtration or purification unit for their apartment.

Postcard parties:

We continue to hold the once/monthly postcard writing parties in the Club Room on the second Sunday of the month. Indivisible Clackamas partners with us; last month we wrote 89 postcards in 90 minutes.

Recycling:




Clean Wind Energy Option for Rose Villa Residents

PGE has extended the opportunity for Rose Villa residents to participate in their Green Source energy program.

How it works:

As you know, all electricity to our campus is provided by Portland General Electric. The power comes from a variety of sources (see chart on left). Some of the sources are



For 2017, the additional Clean Wind comes from Oregon, Washington, date, Utah or Wyoming.

By opting into this program residents can invest in sustainable power and know that their portion of the electric bill is being sourced exclusively by Clean Wind.

What is the cost for me to participate?

To ensure your portion of the Rose Villa Community electricity bill is being sourced exclusively by Clean Wind Power, the cost for each resident is \$3.20/month. This is a voluntary program that we are extending- no one is obligated to participate.

How do I participate?

Easy! Just complete section on the back of this flyer and submit to the Resident Services Counter before Oct 1

What happens next?

If you choose to participate, the business office will add the \$3.20 per person charge to your monthly statement each month. By participating in the program you will receive a welcome goodie bag packet from PGE with information detailing the program, some coupons and a window sticker you can proudly display!
